Application process

- 2. Pay application fee
- 3. Send your educational documents to EBS for evaluation
- 4. Admission interview
- 5. Acceptance

Once the student has sent all necessary documents for applying, has a valid internationally recognized English language test certificate and has successfully passed the entrance requirements (incl. Interview) the Admissions Committee will decide upon the student's admission.
